

**NO-WORRY OF UPFRONT-FEE-PAYMENT PROCEDURE
WHY YOU NEED NOT WORRY FOR PAYING TRANSMISSION FEE?**

Clause 4. Upon receipt the countersigned Deed of Agreement from the beneficiary, the provider issues the signed Corporate Refund Guarantee to the beneficiary **and the issuing bank officer delivers Ready Willing and Able (RWA) With ISIN via bank-to-bank secured Email/Fax. Copy of (RWA) will be forwarded to the beneficiary.**

Note: The ISIN can be verified via Euro Clear - <https://www.euroclear.com/en.html>. The Instrument required will be issued via SWIFT MT 799 followed by SWIFT MT 760.

Following RWA Letter will be sent Bank to Bank before your Transmission Fee payment.

This will be in addition to ISIN that can be verified by Google Search or as above in red link. ISIN means it is an already issued SBLC. Same ISIN will be transferred to your name when you pay minimum \$35,000 for a \$20 Million SBLC.

If you want higher face values of SBLC, then from 2nd Tranche onwards Your Transmission Fee can be paid from your Monetized amount of previous Tranche, if you Monetize with the same provider at 55% LTV.
